For your information, we expect each student to conform to these rules of conduct

No possession or use of alcohol, drugs, or tobacco

No students can drive

No boys in girls' sleeping quarters and no girls in boys' sleeping quarters

Participation with the group is expected

Respect property

Respect one another, staff, and adult leaders

Respect and comply with event schedules

Students who fail to comply with these expectations may be sent home at their parents' expense.

I, the student, have read the rules of conduct, the above evaluation of my health, and permission to participate in the Onward Camp children/youth activities. I agree to abide by the stated personal limitations and code of conduct.

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in entirety. By signing this agreement, you give up your right and the named minor's right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor's participation in True Hope Church's Programs, now or any time in the future.

### ACKNOWLEDGEMENT OF RISK

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with participation in Onward Camp children/youth activities, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Onward Camp children/youth activities participation and that said list in no way limits the operation of this Agreement.

### CORONAVIRUS / COVID-19 WARNING & DISCLAIMER

Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as a mean to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in Onward Camp programs or accessing Quaker Hill's facilities could increase the risk of contracting COVID-19. True Hope Church in no way warrants that COVID-19 infection will not occur through participation in True Hope Church's programs or accessing True Hope Church's or Quaker Hill's facilities.

## WAIVER, RELEASE, INDEMNIFICATION & COVENANT NOT TO SUE

In consideration of the minor named above's participation in Onward Camp I the parent/guardian of the minor named above, agree to release and on behalf of myself and the minor named above, my heirs, representatives, executors, administrators, and assigns, HEREBY DO RELEASE Onward Camp, all participating churches, Quaker Hill and all of their officers, directors, employees, volunteers, agents, representatives and insurers ("Releasees") from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which I, the named minor, my heirs, representatives, executors, administrators and assigns may have, now or in the future, against Onward Camp and its participating churches, on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of facilities/equipment or participation in programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of the named minor's participation in Onward Camp, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor's Onward Camp participation.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in Onward Camp participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in Onward Camp and that by signing this agreement I, on behalf of myself and the named minor, HEREBY RELEASE Releasees of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments which would preclude his/her safe participation in Onward Camp.

This consent form gives permission to seek whatever medical attention is deemed necessary (including COVID-19 testing), and releases True Hope Church and its staff of any liability against personal losses of named child. I/we also agree to bring my/our child home at my/our own expense should they become ill or if deemed necessary by the family ministries staff member. I/we give permission to True Hope Church/Onward Camp to use pictures of my student for promotional purposes.

This release form authorizes the camp nurse or designated adult staff to follow the parent's request according to the original label or physician's orders and communicate with the doctor as needed. True Hope Church cannot assume any liability for consequences, which arise as a result of following the manufacturer's label or doctor's orders.
